Whereas, it has been observed that the day to day operation of passenger services of Assam State Transport Corporation has been badly affected in most of the Divisional Offices and bus stations there under for want of required numbers of man power more particularly in the offices as well as ticket counters and such other work places related to bus operation. That apart, the implementation of Self Employment Scheme i.e. operation of private owned buses (POB) and recently introduced plying of High Tech buses under Public Private Partnership Model (PPP-Model) have also been adversely affected for similar reasons. The circumstances have compelled the Divisional Offices to utilise the services of a section of qualified Security Guards in office as well as in ticket counter (both Online and Offline Ticketing System)

And whereas, in view of exigent requirement of additional manpower, it has been decided to engage some qualified Security Guards having Diploma in Computer Application as Office Assistant (Contractual), subject to their suitability found in computer test and who are presently working under the control of M/S Agni Security Agency, Appointed Private Security Agency of the Corporation. Accordingly, on 08/09/02.2018, total 64 numbers of such qualified Security Guards appeared in the Interview and Computer Application Test conducted in this establishment, of which 40 numbers of such candidates found suitable and selected for their engagement as Office Assistant (Contractual) in different offices of the corporation.



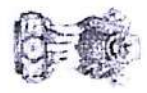

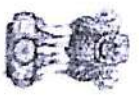
